Consent Form for Transportation of Sentinels - 2018-19 Activities/Sports Participation

The Catholic Diocese of Phoenix "Policy on Sexual Misconduct" provides, in part, that *"field trips or other outings involving a Diocesan student in places and situations where no other responsible adults are present..."* are to be avoided. The directive of this provision requires that two adults (one of whom has successfully completed the

Diocesan Called To Protect-CTP program) should always accompany and transport Seton Catholic students to and from all school-sponsored activities.

Because of the limited number of participants in various activities, practices and/or contests at Seton Catholic High School and the time of day in which the activities, practices and/or contests will occur, it may not always be possible to have two adults (one of whom has completed the CTP program) occupying each vehicle transporting Sentinels to and from those activities, practices and/or contests.

Likewise, it may not be possible or practical to have adults drive all Sentinels to activities, practices and/or contests. Therefore Sentinels will be permitted to drive only themselves and siblings to and from activities, practices and/or contests. _____

The Diocese permits exceptions to this policy only upon a showing by Seton Catholic Preparatory High School that:

- 1) Seton Catholic High School has made reasonable efforts to have two adults (one of whom has completed the CTP program) present in such vehicles, but without success; and
- 2) a parent/guardian of any CTP on Catholic Sentinel participating in such program has consented in writing with notarization in order to allow such student to be transported in another manner.

I understand that I must complete all required information, select the option for transporting my child, sign the document, date the document, and fulfill notarization requirements before this document may be accepted by Seton Catholic Preparatory.
